<b>Content of a course</b>					
<p>With the goal of successful implementation of educational syllabus and introducing students to specific practical problems from business environment, the Department of Informatics organizes specialist internship of 300 hours supervised by a mentor. Before starting internship, a student prepares the practical part working on a special assignment (50 hours). Following the specially defined assignment the student writes a paper which in its final version represents the specialist final paper.</p> <ol style="list-style-type: none"> <li>1.
